Ref: IMAGE Terms and Conditions

Dear Sir/Madam,

This is a reminder regarding the mandatory implementation of the QR code-based collection system for all healthcare establishments affiliated with IMAGE.

Effective immediately, please ensure your organization displays its QR code alongside the biomedical waste during scheduled collection times.

- If the QR code is not clearly visible (e.g., torn or faded), kindly replace it without delay.
- If your operating hours do not align with our collection schedule, please ensure both the waste and the QR code are easily accessible to our collection team.

Please take note of the following important points:

- If the QR code is displayed without the biomedical waste, the collection will be marked as "No Waste."
- If neither the waste nor the QR code is available, your establishment will be marked as "Door Closed."
- Multiple instances of "Door Closed" may result in a temporary suspension of services, with specific conditions for resuming service.

These guidelines are outlined in the IMAGE Terms and Conditions, and your compliance is critical to maintaining uninterrupted service.
